Confirmation/adoption regarding the circulars:


- (i) UGC Letter No. F.9-112013 dated 12 September, 2013 on the formation of Anti-Ragging Cell in Educational Institutions, and

It was unanimously decided that the college will strictly adopt the rules and regulations as per the notifications and accordingly measures will be taken in this matter.


**Item No.3:**




**Item No.3:** Regarding any matters related to complaint, no such cases have been recorded, as a matter of fact; the campus is a ragging free zone.

- (iii) Essay competition on ragging and its effects on the students and the society at large.



- (iii) Essay competition on ragging and its effects on the students and the society at large.


