
## Item No.4:

The minutes of the previous meeting was confirmed by the Chair.


**Item No.2:**


**Item No.3:**

To read and confirm the minutes of the previous meeting of the college minority Committee held on 10<sup>th</sup> November 2021.


**Item No.2:**
