
Item No.3:

The detailed discussion has been taken place related to the OBC students. It has been decided unanimously to guide them and give them proper information about OBC cell.


Item No.4:


Item No.3: Regarding any matters related to complaint, no such cases have been recorded, as a matter of fact; the college is any issue free zone with regards to OBC stakeholders.

Regarding confirmation of the previous meeting of the OBC cell held on 7th August 2020, the house unanimously confirmed the minutes of the previous meeting.


Item No.2:

To read and confirm the minutes of the previous meeting of the OBC Cell held on 30th August 2021.


Item No.2:


Item No.3:

The Cell has discussed about the new rules and regulations related to OBC students implemented by the Government of Maharashtra. The Cell has also discussed about their employment and education.


Item No.3:

It was decided that as per the regulations of the Government of Maharashtra that every students must know about the schemes.


Item No.4:
